

VET FEST - 2017

Vendor Application Contract

The parties to this contract are **Visions Outreach, Inc.** and _____ (hereafter known as the "Vendor"). Whereas, **Visions Outreach, Inc.** is hosting an event known as **Georgia VET FEST 2017**, to occur at **Clayton County International Park 2300 GA-138, Jonesboro, GA 30236** on **September 2, 2017**, beginning approximately at **8:00am** and has the right to license concessions to vendor at and during the event, and whereas, Vendor desires to vend at and during said Event, and whereas, Vendor will pay **Visions Outreach, Inc.** the sum of \$ _____. This fee entitles the vendor to a license to vend at and during said Event. Now, therefore, the parties agree as follows:

1. Vendors shall have access to the location agreed upon by the parties on the day of the event, no earlier than two (2) hours before the event commencement. **September 2, 2017** beginning at 8:00am. Vendor can set up vending station, goods, and other things necessary and reasonable to vending at the location. Each event has a specific commencement time, with the 5k Run/Walk starting at 8:00am
2. Vendor shall not vend any goods or services other than those described herein at and during the event without the **Visions Outreach, Inc's** written consents. **A list of goods or services must be attached to this contract.**
3. Vendor's vending station shall be no larger than 10x10 feet or taller than 16 feet; shall be clean, orderly, and shall comply with all applicable laws and regulations.
4. Vendor's staff may announce the availability of the goods and any "specials" to be sold while they are within the confines of the vendor's location.
5. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly manner at all times.
6. No loud music, noise, or sound amplification devices shall be used by the vendor's staff of the location. All announcements regarding products and/or goods sold will be done by **Visions Outreach, Inc.**
7. Vendor shall have access to the location for up to one (1) hour after the events conclusion at 6:00 pm to dismantle and remove all things brought to the location by Vendor. **Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.**
8. Vendor hereby agrees to indemnify and hold harmless **Visions OutReach, Inc .** and the **city of Jonesboro** against any damages or claims that may arise in connection with Vendors presence at the Event and Vendor's activities of any kind.
